2. Od dana 3. travnja 2025. kao dana otvaranja dijela dopunjene zemljišne knjige za katastarsku općinu Donja Višnjica, samo će upisi u nju, glede nekretnina na kojoj se dopunjeni dio zemljišne knjige za katastarsku općinu Donja Višnjica odnosi, proizvoditi one pravne učinke u vezi stjecanjem, promjenama, prijenosom i ukidanjem prava vlasništva i ostalih knjižnih prava, koji su zakonom određeni za pravne učinke upisa u zemljišne knjige.

3. Danom objave ovog oglasa na e-Oglasnoj ploči otvoren je ispravan postupak glede dopunjene zemljišne knjige katastarske općine Donja Višnjica, pa se sve osobe koje smatraju da bi u tu knjigu trebalo upisati nešto što nije upisano ili da bi trebalo izmijeniti, nadopuniti ili izbrisati neki upis ili njegov prvenstveni red, pozivaju staviti zemljišnoknjižnom sudu svoje prijave prijedloga za upise, odnosno svoje prigovore postojećim upisima ili njihovom prvenstvenom redu u roku od 60 dana od dana objave ovog oglasa na e-Oglasnoj ploči suda (rok za ispravak).

Ukoliko prijave i prigovori nisu podneseni elektronički putem ZIS-a, iste će sud odbaciti.

5. Dok ne istekne rok za prijave i prigovore – 2. lipnja 2025. (60 dana od objave ovog oglasa na e-Oglasnoj ploči) ne smatra se da su upisi u zemljišnoj knjizi za katastarsku općinu Donja Višnjica u odnosu na čestice navedene u točki I. Odluke i Oglasa istiniti i potpuni, time da se navedeni rok od 60 dana ne može produživati, niti je dopušten povrat u prijašnje stanje.
